TRADEMARK RELEASE OF SECURITY INTEREST

THIS TRADEMARK RELEASE OF SECURITY INTEREST is made as of July 21, 2006, by WELLS FARGO BANK, NATIONAL ASSOCIATION (“Wells Fargo”).

WITNESSETH:

WHEREAS, Wells Fargo and Decade Industries, Inc. dba Sanus Systems, a Minnesota corporation (“Decade Industries”), were parties to that certain Trademark Security Agreement dated as of September 24, 2004 (the “Security Agreement”; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement), pursuant to which Decade Industries granted a security interest to Wells Fargo in, among other things, the Trademarks (as defined in the Security Agreement) as security for certain obligations owing by Decade Industries to the financial institutions (collectively, the “Lenders”) from time to time party to that certain Credit Agreement by and among Decade Industries and Wells Fargo, as amended, restated, supplemented or otherwise modified and in effect from time to time, including the Trademarks set forth on Exhibit A hereto; and

WHEREAS, the Security Agreement was recorded by the Assignment Division of the United States Patent and Trademark Office on October 8, 2004 at Reel 2955, Frame 0809; and

WHEREAS, Decade Industries has requested that Wells Fargo release its security interest in the Trademarks and reassign the same to Decade Industries;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Wells Fargo hereby releases its security interest in all of Decade Industries’ right, title and interest in and to all of the following (the “Trademark Collateral”):

(a) all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos, designations, slogans, and other source or business identifiers, designs and general intangibles of like nature, and all prints, tags, brochures, advertisements, signage and labels on which any of the foregoing have appeared or appear, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all applications (except for intent-to-use trademark applications) in connection therewith including, without limitation, any such registrations, recordings and applications, if any, in the United States Patent and Trademark Office, any State thereof, or any other country, and all renewals thereof (each of the foregoing items listed in this paragraph being herein called a “Trademark,” and collectively called the “Trademarks”), including, without limitation,

each Trademark listed on Exhibit A attached hereto (and all amendments, supplements, restatements and modifications thereof or thereto from time to time), and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark;

(b) each agreement granting any right to use any Trademark (each herein called a "Trademark License," and collectively called the "Trademark Licenses"), including, without limitation, each Trademark License listed in Exhibit A (and all amendments, supplements, restatements and modifications thereof or thereto from time to time); and


(c) all substitutions for and improvements, products and proceeds of, and all renewals and replacements of, any of the foregoing, and all general intangibles relating to or arising in connection with any of the foregoing, including, without limitation, any claim with respect to same, including for past, present or future infringement or dilution of any Trademark, or for injury to the goodwill associated with any Trademark, or for unfair competition of any type or nature whatsoever, and all insurance and claims for insurance with respect to same.;

2. Wells Fargo hereby reassigns, grants and conveys to Decade Industries, without any representation, warranty, recourse or undertaking by Wells Fargo, all of Wells Fargo's right, title and interest in and to the Trademark Collateral, and the goodwill of Decade Industries' business connected with the use of and symbolized by the Trademark Collateral.
