**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

**WHEREAS**, the Copyright Security Agreement was recorded with the United States Copyright Office on August 18, 1999, at Volume 3440, Page 179.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee, without representation, warranty or recourse of any kind, hereby terminates the Security Agreements, and hereby terminates, cancels and releases any and all security interests it has against the Grantor's collateral, including the Scheduled Intellectual Property.
