Subject to the Agreement, Gillette hereby authorizes the Buyer, Dial Brands Holdings Inc. and Henkel KGaA, to take any and all actions in connection with such trademarks, trademark registrations and trademark applications, in the name of Dial Brands Holdings, Inc. and Henkel KGaA and at the expense of Dial Brands Holdings, Inc. and Henkel KGaA. All capitalized terms used, but not defined herein, have the meanings set forth in the Agreement.
