TRADEMARK SECURITY AGREEMENT AND CONDITIONAL ASSIGNMENT FOR SECURITY

The term "Loan Agreement" as used herein means the Loan Agreement, dated of even date herewith, by and among Assignee, Lenders, Assignor and certain of its affiliates, as the same may be amended, supplemented, restated or replaced.


