RELEASE OF SECOND LIEN TRADEMARK SECURITY AGREEMENT

This RELEASE, dated as of August 28, 2006, (the "Release") is made by JPMorgan Chase Bank, N.A., a National Banking Association, as Administrative Agent ("JPMorgan"), in favor of Hughes Network Systems, LLC, a Delaware limited liability company ("Hughes"), as follows:

WITNESSETH

WHEREAS, pursuant to the Second Lien Credit Agreement dated as of April 22, 2005 (as amended and restated as of June 27, 2005) and the Grant of Security Interest in U.S. Trademark Rights between Hughes and JPMorgan dated as of June 27, 2005 (the "Security Agreement"), Hughes granted JPMorgan, for the benefit of Bear Stearns Corporate Lending Inc., JPMorgan Chase Bank, N.A., J.P. Morgan Securities Inc. and Bear, Stearns & Co. Inc., a security interest ("Security Interest") in all of Hughes' right, title and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement and including, without limitation, the trademarks on Schedule A attached hereto);

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on July 14, 2005 at Reel/Frame No. 3134/0186;

WHEREAS, Hughes has requested that JPMorgan release its Security Interest in and to the Trademark Collateral;


NOW, THEREFORE, JPMorgan, without recourse, representation or warranty and at Hughes' sole cost and expense, hereby TERMINATES and RELEASES all of its right, title and interest in and to the security interests granted to JPMorgan pursuant to the Trademark Assignment of Security in each of the trademarks set forth in Schedule A, attached hereto and incorporated herein by reference and the registrations of and applications for said trademarks.

JPMorgan agrees to provide Hughes with any information and additional authorization necessary to effect the release of JPMorgan's security interest in the Released Trademark Collateral.
