1 TERMINATION OF SECURITY INTEREST AND ASSIGNMENT

2
3 THIS TERMINATION OF SECURITY INTEREST AND ASSIGNMENT
4 (“Termination and Assignment”) is made as of the 22nd day of June, 2006 by WACHOVIA
5 BANK, NATIONAL ASSOCIATION, a national banking association (“Agent”), in favor of
6 LEBANON SEABOARD CORPORATION, a Pennsylvania corporation formerly known as
7 “Lebanon Chemical Corporation” (“Company”).
8

9 BACKGROUND

10
11 A. Pursuant to the provisions of a Loan and Security Agreement dated as of April 1,
12 2004 (as amended, the “Credit Agreement”) among Company, those certain financial institutions
13 identified as Lenders thereunder (collectively, the “Lenders”) and Agent, acting as agent for the
14 benefit of the Lenders, Company, among other things, granted Agent a lien on, and security
15 interest in, substantially all of Company’s assets as collateral security for Company’s obligations
16 under the Credit Agreement.
17

18 B. In connection with the transactions contemplated by the Credit Agreement, Company
19 and Agent entered into a Patents, Trademarks, Copyrights and Licenses Security Agreement
20 dated as of April 1, 2004 (the “Security Agreement”) further evidencing Agent’s lien on, and
21 security interest in, certain of Company’s intellectual property assets more-fully described
22 therein (including, without limitation, the patents, patent applications, trademarks and trademark
23 applications identified on Schedule “A” attached hereto), which Security Agreement was
24 recorded on behalf of Agent in the United States Patent and Trademark Office (the “USPTO”).
25 Capitalized terms used in this Termination and Assignment which are not otherwise defined
26 herein shall have the respective meanings given to such terms in the Security Agreement.
27

28 C. Company has repaid or otherwise satisfied all of its obligations to Agent and the
29 Lenders under the Credit Agreement in full, and Company has requested that Agent, and Agent
30 has agreed to, execute and deliver this Termination and Assignment to Company in order to
31 further evidence (1) the termination of Agent’s lien on, and security interest in, all of the Assets
32 and (2) the assignment by Agent of all of its right, title and interest in, to and under all of the
33 Assets to Company.
34

35 NOW, THEREFORE, Agent, for good and valuable consideration, the receipt and
36 sufficiency of which are hereby acknowledged, and intending to be legally bound hereby,
37 covenants and agrees as follows:
38

39 1. Incorporation of Background. The Background provisions set forth above (including,
40 without limitation, all defined terms set forth therein) are hereby incorporated herein by
41 reference and made a part of this Termination and Assignment as if set forth in their entirety in
42 this Section 1.
43

44 2. Termination of Lien and Security Interest and Assignment of Rights. The liens and
45 security interests granted by Company to Agent pursuant to the Credit Agreement and the
46 Security Agreement in and to all of the Assets (and all of Company’s rights with respect thereto)

1 are hereby terminated, and Agent hereby assigns, transfers, conveys and releases and sets over
2 unto Company, without recourse, Agent's entire right, title and interest in, to and under all of the
3 Assets, together with all rights appurtenant thereto (including the right to sue for past, present
4 and future infringements, and the proceeds thereof and the applications and registrations with
5 respect thereto).
6

7 3. Recording Authorization. Company is authorized to record this Termination and
8 Assignment with the USPTO and any other governmental authority in any jurisdiction that
9 Company, in its discretion, deems necessary or appropriate.
10

11 4. Further Actions. From time to time after the date hereof Agent shall, at Company's
12 expense, promptly take such actions and execute and deliver such documents and instruments as
13 Company or its counsel may reasonably request in order to (a) evidence the termination of
14 Agent's liens and security interests with respect to the Assets and (b) perfect and record
15 Company's ownership rights in the Assets.
16

17 5. Successors, etc. This Termination and Assignment and all of the terms, covenants and
18 provisions hereof shall inure to the benefit of Company and its successors and assigns and shall
19 be binding upon Agent and its successors and assigns.
20

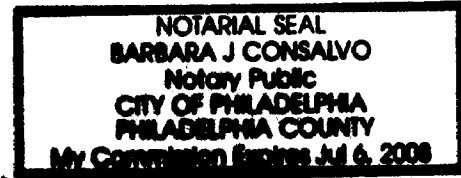
