TRADEMARK SECURITY AGREEMENT

This TRADEMARK SECURITY AGREEMENT ("Agreement") is made and entered into as of the 31st day of August, 2006 between Plymouth Rubber Company, Inc., a corporation organized under the laws of the Commonwealth of Massachusetts, and having a business address of 104 Revere Street, Canton Massachusetts 02021 (hereinafter referred to as "Trademark Owner") and PRC-BL Funding, LLC and PRC-BL Funding Parallel, LLC, jointly and severally, which are limited liability companies organized under the laws of the State of Delaware, and having a business address c/o Chrysalis Capital Partners, L.P., Cira Centre, 2929 Arch Street, Philadelphia, PA 19104-2860 (hereinafter referred to as "Funding Entities").

Whereas Trademark Owner and the Funding Entities having entered into a Security Agreement on the 31st day of August, 2006, which relates to, at least in part, the Intellectual Property of Trademark Owner, and wherein all of the terms and conditions of the aforesaid Security Agreement are hereby incorporated herein by reference; and

Whereas Funding Entities require a separate recordable document memorializing their respective Security Interests in and to all of the marks, registrations and applications listed in Schedule A hereto;

NOW THEREFORE, in consideration of the premises and mutual covenants of the parties hereto, and intending to be legally bound hereby, it is hereby agreed as follows:

1. Assignment of Security Interest in Marks. To secure the complete and timely payment and satisfaction of all of its Obligations to the Funding Entities, the Trademark Owner hereby grants, assigns and conveys to the Funding Entities a security interest in and to all of Trademark Owner's trademarks (whether registered, unregistered or for which any actual use-based application to register has been filed), trademark applications, service mark applications, service marks (whether registered, unregistered or for which any actual use-based application to register has been filed) and tradenames, all of which are listed in Schedule A hereto (as the same may be amended pursuant hereto from time to time), including, without limitation, all renewals thereof and all proceeds thereof (such as, by way of example, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights owned by Trademark Owner corresponding thereto throughout the world (all of the foregoing are collectively called the "Marks"), together with the goodwill of the business symbolized by each of the Marks and the registrations (if any) thereof.

2. Future Marks. The Trademark Owner authorizes the Funding Entities to modify this Agreement by amending Schedule A to include any future trademarks, service marks or tradenames which are Marks under paragraph 1 hereof.
