#### TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment"), effective as of the day of <u>Account</u>, 2006 (the "Effective Date"), is made between PURSELL TECHNOLOGIES, INC., an Alabama corporation ("Assignor"), and AGRIUM POLYMER COATINGS CORP., a Delaware corporation ("Assignee").

WHEREAS, Assignee, pursuant to the Purchase Agreement, desires to acquire the Marks and any and all goodwill of the business associated therewith from Assignor, subject to the terms and conditions of this Assignment; and

WHEREAS, Assignor and Assignee desire to confirm of record the assignment of the Marks and goodwill to Assignee;

NOW, THEREFORE, in consideration of the foregoing recitals, the mutual covenants and conditions contained herein, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree as follows:

- 1. Assignor hereby assigns to Assignee all right, title and interest in and to the Marks, together with: (i) the goodwill symbolized by or associated with the Marks; (ii) all causes of action, claims and demands and other rights for, or arising from, any infringement or misappropriation, including past infringements and misappropriations, of the Marks; and (iii) any royalties or other consideration owed in connection with use of the Marks after the Effective Date.
- 2. Assignor further agrees without further consideration to cause to be performed such other lawful acts and to be executed such further assignments and other lawful documents as Assignee may from time to time reasonably request to effect fully this Assignment and to permit Assignee to be duly recorded as the registered owner of the Marks, goodwill and all other rights hereby conveyed.
- 3. Nothing expressed or implied in this Assignment shall be deemed to be an assumption by Purchaser or any of its Affiliates (as defined in the Purchase Agreement), successors, or assigns of any liabilities or obligations related to or arising under the Marks prior to the Effective Date.
- 4. Subject to the terms hereof, Assignee accepts such assignment of the Marks and goodwill.
