FIRST AMENDMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS FIRST AMENDMENT TO INTELLECTUAL PROPERTY SECURITY AGREEMENT (this "Amendment") is entered into as of the 11th day of September, 2006, by and among GOODY'S FAMILY CLOTHING, INC., a Tennessee corporation ("GFCI"), SYDOOG LLC, a Delaware limited liability company ("Sydoog"), and GOODY'S MS, L.P., a Tennessee limited partnership ("Goody's MS", and together with GFCI and Sydoog, collectively referred to herein as the "Grantors" and each individually referred to herein as a "Grantor"), each located at 400 Goody's Lane, Knoxville, Tennessee 37922, and THE CIT GROUP/BUSINESS CREDIT, INC., a New York corporation located at 1211 Avenue of the Americas, New York, New York 11036, as Collateral Agent for the Secured Parties (in such capacity, the "Collateral Agent").

WITNESSETH:

WHEREAS, the Grantors have entered into that certain Intellectual Property Security Agreement dated as of March 8, 2006 in favor of the Collateral Agent (as amended, restated, supplemented or otherwise modified from time to time, the "IP Security Agreement"); and

WHEREAS, the Collateral Agent and the Grantors desire to amend the IP Security Agreement in accordance with this Amendment.

NOW, THEREFORE, for and in consideration of the premises and mutual agreements herein contained and for the purposes of setting forth the terms and conditions of this Amendment, the parties, intending to be bound, hereby agree as follows:

- 1. <u>Incorporation of the IP Security Agreement</u>. All capitalized terms which are not defined in this Amendment shall have the same meanings as set forth in the IP Security Agreement, and the IP Security Agreement, to the extent not inconsistent with this Amendment, is incorporated herein by this reference as though the same were set forth in its entirety. To the extent any terms and provisions of the IP Security Agreement are inconsistent with the amendment set forth in <u>Section 2</u> below, such terms and provisions shall be deemed superseded hereby.
- 2. <u>Amendment of the IP Security Agreement</u>. The parties hereto hereby agree to amend the IP Security Agreement as follows:
- (a) <u>Schedule II</u> to the IP Security Agreement is hereby amended and restated in its entirety, to read as set forth on <u>Schedule II</u> attached hereto.
- 3. <u>Ratification</u>. Except as expressly amended hereby, the IP Security Agreement is hereby ratified and confirmed by the parties hereto and remains in full force and effect in accordance with the terms thereof.
- 4. <u>Representations and Warranties</u>. Each Grantor hereby represents and warrants to the Collateral Agent and the Secured Parties that the representations and warranties contained in the IP Security Agreement are true and correct in all material respects on and as of the date hereof, as though made on and as of such date (except to the extent such representations and

warranties relate solely to an earlier date in which case such representations and warranties are true and correct in all material respects as of such earlier date).

- 5. GOVERNING LAW. THIS AMENDMENT AND THE OBLIGATIONS ARISING HEREUNDER SHALL IN ALL RESPECTS, INCLUDING ALL MATTERS OF CONSTRUCTION, VALIDITY AND PERFORMANCE, BE GOVERNED BY, AND CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK APPLICABLE TO CONTRACTS MADE AND PERFORMED IN SUCH STATE, AND ANY APPLICABLE LAWS OF THE UNITED STATES OF AMERICA.
- 6. <u>Counterparts</u>. This Amendment may be executed in two or more counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same instrument. Delivery of an executed counterpart of this Amendment by facsimile or by ".PDF" shall be equally as effective as delivery of an original executed counterpart of this Amendment.
