### INTELLECTUAL PROPERTY SECURITY AGREEMENT SUPPLEMENT

This INTELLECTUAL PROPERTY SECURITY AGREEMENT SUPPLEMENT (this "IP Security Agreement Supplement") dated September 28, 2006, is made by Cardinal Brands, Inc., a Nevada corporation (the "Grantor") in favor of U.S. Bank National Association, a national banking association, as agent (in such capacity, the "Agent") for itself and the other present and future holders of the Borrower's Obligations (as such term is defined in the Amended Credit Agreement referenced below). Terms used but not otherwise defined herein have the meaning ascribed thereto by the Amended Credit Agreement (as defined below).

WHEREAS, the Grantor has entered into a Revolving and Term Loan Credit Agreement dated as of December 29, 2004 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Existing Credit Agreement"), with the Agent and the Lenders party thereto.

WHEREAS, Cardinal Brands, Inc., a Nevada corporation, has entered into an Amended and Restated Credit Agreement dated as of the date hereof (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Amended Credit Agreement"), with the Agent and the Lenders party thereto.

WHEREAS, pursuant to the Existing Credit Agreement, the Grantor executed and delivered that certain Security Agreement dated as of December 29, 2004 in favor of the Agent for the benefit of the Existing Lenders (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement") and that certain Patent, Trademark and License Security Agreement dated as of December 29, 2004 in favor of the Agent for the benefit of the Existing Lenders (as amended, amended and restated, supplemented or otherwise modified from time to time, the "IP Security Agreement").

WHEREAS, under the terms of that certain Affirmation and Amendment of Collateral Documents dated of the date hereof (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Affirmation"), the Grantor has granted to the Agent, for the ratable benefit of the Lenders, a security interest in the Additional IP Collateral (as defined in Section 1 below) of the Grantor and has agreed as a condition thereof to execute this IP Security Agreement Supplement for recording with the U.S. Patent and Trademark Office, the United States Copyright Office and other governmental authorities.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor agrees as follows:

SECTION 1. <u>Grant of Security</u>. Each Grantor hereby grants to the Agent, for the ratable benefit of the Lenders, a security interest in all of such Grantor's right, title and interest in and to the following (the "Additional IP Collateral"):

- (i) the patents set forth in Schedule A hereto (the "Patents");
- (ii) the patent applications set forth in Schedule B hereto (the "Patent Applications");

- (ii) the patent applications set forth in <u>Schedule B</u> hereto (the "Patent Applications");
- (iii) the trademark and service mark registrations set forth in <u>Schedule C</u> hereto (provided that no security interest shall be granted in United States intent-to-use trademark applications to the extent that, and solely during the period in which, the grant of a security interest therein would impair the validity or enforceability of such intent-to-use trademark applications under applicable federal law), together with the goodwill symbolized thereby (the "*Trademarks*");
- (iv) the trademark and service mark applications set forth in <u>Schedule D</u> hereto (provided that no security interest shall be granted in United States intent-to-use trademark applications to the extent that, and solely during the period in which, the grant of a security interest therein would impair the validity or enforceability of such intent-to-use trademark applications under applicable federal law), together with the goodwill symbolized thereby (the "*Trademark Applications*");
- (v) the licenses and design agreements set forth in Schedule E hereto (the "Licenses");
- (vi) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto;
- (vii) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and

The grant of a security interest in the Additional IP Collateral by the Grantor under this IP Security Agreement Supplement secures the payment of all Borrower's Obligations now or hereafter existing under or in respect of the Transaction Documents, whether direct or indirect, absolute or contingent, and whether for principal, reimbursement obligations, interest, premiums, penalties, fees, indemnifications, contract causes of action, costs, expenses or otherwise.
- SECTION 3. <u>Recordation</u>. The Grantor authorizes and requests that the Register of Copyrights, the Commissioner for Patents and the Commissioner for Trademarks and any other applicable government officer to record this IP Security Agreement Supplement.

SECTION 5. <u>Governing Law</u>. This IP Security Agreement Supplement shall be governed by, and construed in accordance with, the laws of the State of Missouri.
