RELEASE OF SECURITY INTEREST

This Release of Security Interest "Release", is granted as of October 31, 2006, by ComVest Investment Partners II LLC ("ComVest"), to Fischer Imaging Corporation ("Fischer").

WITNESSETH THAT:

WHEREAS, Fischer and ComVest entered into a Note and Warrant Purchase Agreement dated as of February 22, 2005 (the "Note Purchase Agreement"), under which certain Senior Secured Promissory Notes (the "Notes") were issued and security interests in certain patents, trademarks and other collateral of Fischer (the "Secured Property") were granted to ComVest as described in a Security Agreement between ComVest and Fischer dated February 22, 2005 (the "Security Agreement", and together with the Note Purchase Agreement and the Notes, the "Agreements"); and

WHEREAS, all of the obligations of Fischer under each of the Agreements have been satisfied by Fischer as of September 29, 2005, and the parties wish to confirm that as of such date ComVest had no further security interest in the Secured Property and to have ComVest authorize the release of any security interest ComVest may continue to have recorded therein;

NOW, THEREFORE, in consideration of the foregoing and in further consideration of Fischer's satisfaction of its obligations under the Agreements, ComVest hereby unconditionally and irrevocably:


1. Releases and discharges the Secured Property from any lien, security interest or other encumbrance created by the Agreements or United States Patent and Trademark Office ("USPTO") recordations that may have been filed or recorded by ComVest;
2. Remises and quitclaims, to the present owner or owners thereof, all of its interest in and to the Secured Property, free and clear of all right, title, interest or claim of any nature on the part of ComVest under or by virtue of the Agreements or USPTO recordations that may have been filed or recorded by ComVest;
3. Authorizes Fischer or its agents to record or file, on behalf of Fischer, termination statements with the USPTO with respect to ComVest's interest in the Secured Property under the Agreements; and
4. Agrees to provide Fischer at Fischer's expense with any other documentation reasonably requested by Fischer to release ComVest's security interest in the Secured Property and all liens of ComVest on the assets of Fischer.
