ABL TRADEMARK SECURITY AGREEMENT dated as of October 26, 2006 (this "*Agreement*"), among PETCO ANIMAL SUPPLIES STORES, INC., a Delaware corporation, located at 9125 Rehco Road, San Diego, California 90025 ("*PETCO*", successor by merger to PETCO Animal Supplies, Inc.), the undersigned Subsidiaries of PETCO party hereto (together with PETCO, the "*Assignors*") and WELLS FARGO RETAIL FINANCE, LLC, a Delaware limited liability company, located at One Boston Place, 18th Floor, Boston, Massachusetts 02108, as collateral agent (in such capacity, the "*Assignee*").

The Loan Parties, the Assignee, Credit Suisse, as administrative agent, and the Lenders are entering into a Credit Agreement dated as of the date hereof providing for a revolving facility in an aggregate principal amount of up to \$200,000,000 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "*Credit Agreement*").

The Assignors are entering into a Security Agreement in order to induce the Lenders to enter into and extend credit to the Borrower under the Credit Agreement and to secure the Secured Obligations, including in the case of each Grantor that is a Loan Guarantor, its obligations under the Loan Guaranty.

The Assignors and Assignee are entering into this Agreement in order to induce the Lenders to enter into and extend credit to the Borrower under the Credit Agreement and to secure the Secured Obligations.

Accordingly, the parties hereto agree as follows:

SECTION 1. *Terms*. Capitalized terms used in this Agreement and not otherwise defined herein have the respective meanings specified in the Security Agreement or the Credit Agreement, as applicable. The rules of construction specified in Article I of the Security Agreement also apply to this Agreement.

SECTION 2. *Grant of Security Interest*. The Assignors, pursuant to the Security Agreement, did and hereby do grant to the Assignee, on behalf of and for the ratable benefit of the Secured Parties, a security interest in all of its right, title or interest in, to and under all personal property and other assets, whether now owned by or owing to, or hereafter acquired by or arising in favor of Assignors, and regardless of where located, including the following (collectively, the "*Trademark Collateral*") :

(a) (i) all trademarks (including service marks), trade names, trade dress, and trade styles and the registrations and applications for registration thereof, including those listed on Schedule I (the "*Trademarks*") and the goodwill of the business symbolized by the foregoing; (ii) all licenses of the foregoing, whether as licensee or licensor; (iii) all renewals of the foregoing; (iv) all income, royalties, damages, and payments now or hereafter due or payable with respect

thereto, including, without limitation, damages, claims, and payments for past and future infringements thereof; (v) all rights to sue for past, present, and future infringements of the foregoing, including the right to settle suits involving claims and demands for royalties owing; and (vi) all rights corresponding to any of the foregoing throughout the world;

(b) all accessions to, substitutions for and replacements, proceeds (including Stock Rights), insurance proceeds and products of the foregoing, together with all books and records, customer lists, credit files, computer files, programs, printouts and other computer materials and records related thereto and any General Intangibles at any time evidencing or relating to any of the foregoing;

to secure the prompt and complete payment and performance of the Secured Obligations.

Notwithstanding the foregoing or anything herein to the contrary, in no event shall the "Trademark Collateral" include or the security interest attach to any Excluded Asset.

**SECTION 3. *Security Agreement.*** The security interests granted to the Assignee herein are granted in furtherance, and not in limitation of, the security interests granted to the Assignee pursuant to the Security Agreement. The Assignors hereby acknowledge and affirm that the rights and remedies of the Assignee with respect to the Trademark Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Security Agreement, the terms of the Security Agreement shall govern.

**SECTION 4. *Intercreditor Agreement.*** REFERENCE IS MADE TO THE INTERCREDITOR AGREEMENT. NOTWITHSTANDING ANY OTHER PROVISION CONTAINED HEREIN, THIS AGREEMENT, THE LIENS CREATED HEREBY AND THE RIGHTS, REMEDIES, DUTIES AND OBLIGATIONS PROVIDED FOR HEREIN ARE SUBJECT IN ALL RESPECTS TO THE PROVISIONS OF THE INTERCREDITOR AGREEMENT AND, TO THE EXTENT PROVIDED THEREIN, THE APPLICABLE SENIOR SECURED OBLIGATIONS SECURITY DOCUMENTS (AS DEFINED IN THE INTERCREDITOR AGREEMENT). IN THE EVENT OF ANY CONFLICT OR INCONSISTENCY BETWEEN THE PROVISIONS OF THIS AGREEMENT AND THE INTERCREDITOR AGREEMENT, THE PROVISIONS OF THE INTERCREDITOR AGREEMENT SHALL CONTROL.

**SECTION 5. *Choice of Law.*** THIS AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.


