**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This Release of Security Interest in Trademarks, dated as of December 20, 2006, is made by Bank of America, N.A., as administrative agent for the banks and other financial institutions (collectively, the "Lenders") party to the Credit Agreement referred to below (in such capacity, the "Administrative Agent"), in favor of America's Drive-In Corp. (the "Pledgor"). Except as otherwise provided herein, capitalized terms used herein but not otherwise defined have the meanings set forth (or incorporated) in the Security Agreement (as is defined below).

WHEREAS, Sonic Corp., a Delaware corporation, together the Guarantors, entered into that certain Credit Agreement dated as of September 14, 2006 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement") with the Lenders, Agents from time to time parties thereto, and the Administrative Agent, which provides for the availability of certain credit facilities to the Borrower upon the terms and subject to the conditions set forth therein.

WHEREAS, as a condition to the extension of credit to the Borrower under the Credit Agreement, the Pledgor executed and delivered that Security Agreement dated as of September 14, 2006, made by the Grantors to the Administrative Agent (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement").

WHEREAS, under the terms of the Security Agreement, the Pledgor granted to the Administrative Agent, for the benefit of the holders of the Secured Obligations, a security interest in, among other Collateral, certain Trademarks of the Pledgor (the "Trademark Collateral"), and as a condition thereof executed that certain Notice of Grant of Security Interest in Trademarks dated September 2006 (the "IP Security Agreement") for recording with the United States Patent and Trademark Office.

WHEREAS, the IP Security Agreement was recorded in the United States Patent and Trademark Office on October 23, 2006 at Reel/Frame 3413/0893; and

WHEREAS, the Administrative Agent has agreed to release, terminate, discharge and convey its security interest in the Trademark Collateral and grant all of its right, title and interest in the Trademark Collateral to the Pledgor;

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all Secured Obligations secured by the Trademark Collateral pursuant to the Security Agreement, the receipt and sufficiency of which is hereby acknowledged, the Administrative Agent agrees as follows:

1. The Administrative Agent hereby releases, terminates, discharges and conveys to the Pledgor that security interest in all of such Pledgor's right, title and interest of every kind and nature in and to the Trademark Collateral, together with all proceeds and rights associated therewith, and all goodwill of the businesses connected with the use of, and symbolized by, the Trademark Collateral, including without limitation the Trademarks listed on Schedule 1, granted pursuant to the Security Agreement or the IP Security Agreement.

2. At Pledgor's expense, the Administrative Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to affect the release of the security interest contemplated hereby.

IN WITNESS WHEREOF, the Administrative Agent has caused this Release of Security Interest in Trademarks to be duly executed as of the date above first written.
