## ASSIGNMENT

(a) The right to sue and recover for, and the right to profits or damages due or accrued arising out of or in connection with, any and all past, present or future infringements or dilution of or damage or injury to the Mark or the registrations thereof or goodwill associated therewith;

(b) the right to apply to secure registrations therein in Assignee's own name and to apply to secure renewals and extension of the registrations and applications for registrations in the United States of America or any other country; and

(c) the right to determine, in Assignee's sole discretion whether or not any registrations or applications for registration of the Mark shall be preserved and maintained or registered.

ASSIGNOR further agrees, at the request of the Assignee and without charge or cost to Assignee, to execute and have executed any and all other documents of any kind whatsoever, that may be reasonably required to carry out the terms and intent of this Assignment.
