**PATENT AND TRADEMARK SECURITY AGREEMENT
(Mezzanine Facility)**

This Agreement, dated as of January 26, 2007, is made by and between Rotonics Manufacturing Inc., a Delaware corporation (the "Debtor"), and Wells Fargo Bank, National Association, a national banking association, as administrative agent (in such capacity, the "Secured Party") for the Lenders, as defined in the Credit Agreement described below.

Pursuant to a Term Credit Agreement (together with all amendments, modifications and restatements of such agreement, the "Credit Agreement") of even date herewith among the Debtor, the Secured Party and various Lenders, as defined therein, the Lenders have agreed to make advances and grant certain other financial accommodations to the Debtor.

As a condition to making any loan or advance under the Credit Agreement, the Lenders have required the execution and delivery by the Debtor of a Security Agreement (together with all amendments, modifications and restatements of such agreement, the "Senior Security Agreement") of even date herewith, pursuant to which the Debtor has granted the Secured Party a security interest in substantially all of the Debtor's personal property, including the Debtor's Patents and Trademarks.

ACCORDINGLY, in consideration of the mutual covenants contained in the Loan Documents and herein, the parties hereby agree as follows:

1. Definitions.

All terms defined in the Recitals hereto or in the Credit Agreement and the Senior Security Agreement that are not otherwise defined herein shall have the meanings given to them therein.

2. Security Interest.

The Debtor hereby confirms that, pursuant to the Senior Security Agreement, it has granted the Secured Party a security interest in the Patents and Trademarks to secure payment of the Obligations. As set forth in the Senior Security Agreement, the Security Interest includes a security interest in substantially all of the personal property of the Debtor, including the Patents listed on Exhibit A attached hereto and the Trademarks listed on Exhibit B attached hereto (as the same may be amended upon acceptance by the Secured Party of replacement exhibits in accordance with the Debtor's obligations under Sections 3(f)(i) and (ii) of the Senior Security Agreement). The Security Interest contained in this Agreement is granted in conjunction with the Security Interest granted pursuant to the Senior Security Agreement. This Agreement grants only the Security Interest herein described, is not intended to and does not affect any present transfer of title of any trademark registration or application, and makes no assignment and grants no right to assign or perform any other action with respect to any intent to use trademark application, unless such action is permitted under 15 U.S.C. § 1060.

The Debtor hereby acknowledges and affirms that the rights and remedies of the Secured Party with respect to the Security Interest in the Patents and Trademarks made and granted hereby are more fully set forth in the Senior Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.
