TRADEMARK RELEASE

This TRADEMARK RELEASE is made as of January 31, 2007, by KeyBank National Association, as administrative agent (the "*Administrative Agent*") in favor of CooperVision Technology LLC, a Delaware corporation ("*CooperVision*").

WITNESSETH:

WHEREAS, the Administrative Agent and CooperVision were parties to that certain Collateral Assignment of Trademarks, dated as of January 6, 2005, as amended, restated, supplemented or otherwise modified (the "*Security Agreement*"), pursuant to which CooperVision granted a security interest to the Administrative Agent in certain trademark registrations and applications (the "*Trademarks*"), and the goodwill associated therewith, including, without limitation, those set forth on Exhibit A hereto;

WHEREAS, the Administrative Agent recorded a security interest with the United States Patent and Trademark Office on April 7, 2005 at Reel 3086, Frame 0207; and

WHEREAS, CooperVision has requested that the Administrative Agent release its security interest in the Trademarks, as defined in the Security Agreement in connection with the termination of the Credit Agreement, and the Security Agreement (the "Released Collateral").

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. The Administrative Agent hereby releases, reassigns, grants and conveys to CooperVision, without recourse, all of its security interest in the Intellectual Property Collateral, listed on Schedule I attached hereto and incorporated herein by reference.
2. The Administrative Agent agrees to provide the Grantors with any information and additional authorization necessary to effect the release of its security interest in the Released Collateral.
