ZERO HALLIBURTON TRADEMARK ASSIGNMENT AGREEMENT

This Zero Halliburton Trademark Assignment Agreement (the "Trademark Assignment") is delivered as of December 29, 2006, by Zero Manufacturing, Inc., a Delaware corporation ("Assignor"), to Zero Halliburton Incorporated, a Delaware corporation (the "Assignee").

WHEREAS, Assignor, Ace Co., Ltd. ("Ace") and Assignee are parties to that certain Stock and Asset Purchase Agreement dated as of December 15, 2006 (the "Purchase Agreement"), pursuant to which Assignor has agreed to transfer, assign, convey, grant and deliver certain Assets to Assignee and thereafter Ace will acquire all of the capital stock of Assignee and certain-trademarks and related goodwill of Assignor as specified below; and

WHEREAS, Ace is currently the exclusive distributor in Japan of products sold under the Trademarks;

NOW, THEREFORE, for and in consideration of the premises and the mutual covenants contained herein, and for other good and valuable consideration, the receipt, adequacy and legal sufficiency of which are hereby acknowledged, the parties do hereby agree as follows:

1. *Capitalized Terms.* Capitalized terms used but not defined herein shall have the meanings for such terms that are set forth in the Purchase Agreement.

2. *The Trademarks.* The "Trademarks" shall mean the trademarks listed on Annex A hereto, and all trademark rights in or to such trademark; provided, however, that in connection with the consummation of the transactions contemplated by the Purchase Agreement the rights in and to the trademarks referred to on Annex B in, and only in, the nation of Japan, shall be assigned to Ace and shall not be transferred to Assignee hereunder and the term Trademark shall not include the rights in and to such trademarks and related goodwill in the nation of Japan.

3. *Ownership and Assignment.* Effective as of the Effective Time, Assignor assigns to Assignee any and all ownership, rights, titles and interests that Assignor may have in or to the Trademarks. This assignment further includes an assignment to Assignee of the goodwill in the Trademarks and the goodwill of the business associated with and symbolized by the Trademarks. This assignment also includes an assignment of any and all registrations and applications for registration of the Trademark, including those identified in Annex A, and as to any applications based on intent to use under Section 1(b) of the U.S. Trademark Act, together with that portion of the business of the applicant to which the mark pertains, as an ongoing and existing business.

4. *Geographic Scope of Assignments.* Except as provided in Section 2, these assignments are given on a world-wide basis, and are not limited geographically. Except as provided in Section 2, these assignments include assignments of all trademark rights in or to the Trademark under the laws of all countries and jurisdictions.

5. *Warranty Disclaimer.* ASSIGNOR MAKES NO WARRANTY, EXPRESS OR IMPLIED, WITH RESPECT TO THE TRADEMARKS PURSUANT TO THIS AGREEMENT, ANY AND ALL SUCH WARRANTIES BEING SET OUT IN THE PURCHASE AGREEMENT.

6. *Counterparts.* This Trademark Assignment may be executed in any number of counterparts, each of which when so executed and delivered shall be an original, but all of which together shall constitute one and the same instrument, and it shall not be necessary in making proof of this Trademark Assignment to produce or account for more than one such counterpart.

7. *Facsimile.* A facsimile or other electronic transmission of an executed Trademark Assignment shall have the same effect as the delivery of the original executed copy of such document; provided, that the parties shall deliver, or cause to be delivered, original signatures to this Trademark Assignment and all of the documents executed in connection herewith on or before January 16, 2007

8. *Governing Law.* This Agreement will be governed by and construed under the laws of the State of Utah without regard to conflicts-of-laws principles that would require the application of any other law.

9. *No Third Party Rights.* Nothing expressed or referred to in this Agreement will be construed to give any Person other than the parties to this Agreement any legal or equitable right, remedy or claim under or with respect to this Agreement or any provision of this Agreement.
