MCG Finance hereby further agrees to take any and all further actions, and to execute and deliver, and to provide Grantors, their successors, assigns or other legal representatives, any and all such documents or other instruments, reasonably requested by the Grantors to evidence, give effect to and perfect the release of the security interest hereunder and the termination of the security agreements referenced above.
