## TRADEMARK ASSIGNMENT

Assignor shall reasonably cooperate with Assignee in executing appropriate documents provided by Assignee required for completing the formalities to secure to such Assignee the rights transferred hereby, upon request of Assignee.


**Except as expressly provided otherwise in the Acquisition Agreement, dated December 20, 2006, between Assignor and Assignee (the "Acquisition Agreement"):** (x) Assignor conveys the Mark to Assignee AS IS, (y) Assignor does not warrant the validity or enforceability of the Mark, and (z) Assignor disclaims all implied warranties relating to the Mark, including without limitation the implied warranties of merchantability, fitness for a particular purpose, title and non-infringement.

In the event of any conflict between this Trademark Assignment and the Acquisition Agreement, the terms of the Acquisition Agreement shall control.


