ASSIGNMENT OF SECURITY INTEREST IN CERTAIN TRADEMARKS

This ASSIGNMENT OF SECURITY INTEREST IN CERTAIN TRADEMARKS (this "<u>Assignment</u>") is made as of February 21, 2007, by and between SUNTRUST BANK, a Georgia banking corporation (the "<u>Existing Administrative Agent</u>"), and THE CIT GROUP/BUSINESS CREDIT, INC. - A. The Existing Administrative Agent, in its capacity as Administrative Agent for the Lenders, hereby assigns and conveys, without representation, warranty or recourse, in the Trademark Security Agreement and all of its security interest in, to and under the Trademark Collateral to Successor Administrative Agent, in its capacity as Administrative Agent for the Lenders.
- 2. This Assignment of Security Interests in Certain Trademarks shall be governed by and construed and enforced in accordance with the laws of the State of New York.
