ASSIGNMENT OF TRADEMARKS

- 3. All right, title and interest in the Trademarks shall be held and enjoyed by Assignee, for its own use and benefit and for the use and benefit of its successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by the Selling Parties if this Assignment had not been made. Without limitation to the foregoing, Selling Parties assign with the Trademarks all associated income, royalties, damages and payments due from or payable by any third party (including, without limitation, damages and payments for past, present, or future infringements or misappropriations thereof) and any and all corresponding rights that, now or hereafter, may be secured throughout the world.
- 4. Each of the Selling Parties agrees, upon the request of Assignee, from time to execute and deliver to Assignee all such additional instruments and documents as shall be reasonably required to perfect and record the conveyance of the Trademarks (including such instruments, powers of attorney and other documents as may be necessary to perfect and record the conveyance of the Trademark
