
WHEREAS, the parties desire to confirm and ratify said assignment.

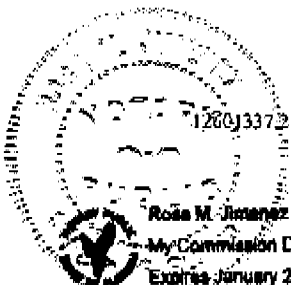

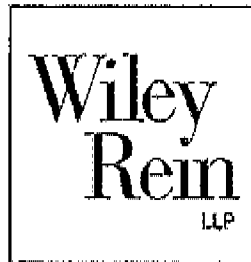
