**AMENDED AND RESTATED GRANT OF TRADEMARK SECURITY INTEREST**

NOTWITHSTANDING ANYTHING HEREIN TO THE CONTRARY, THE LIEN AND SECURITY INTEREST GRANTED TO SECURED PARTY PURSUANT TO THIS GRANT AND THE EXERCISE OF ANY RIGHT OR REMEDY BY THE SECURED PARTY HEREUNDER ARE SUBJECT TO THE PROVISIONS OF THE AMENDED AND RESTATED SUBORDINATION AGREEMENT, DATED AS OF APRIL \_\_, 2007 (AS AMENDED, RESTATED, SUPPLEMENTED OR OTHERWISE MODIFIED FROM TIME TO TIME, THE "**SUBORDINATION AGREEMENT**"), BY AND AMONG READY PAC FOODS, INC., CALIFORNIA COMMERCIAL FINANCING LLC AS COLLATERAL AGENT FOR THE HOLDERS (IN SUCH CAPACITY, THE "**JUNIOR CREDITOR**") AND WELLS FARGO FOOTHILL, INC., AS SENIOR CREDITOR. IN THE EVENT OF ANY CONFLICT BETWEEN THE TERMS OF THE SUBORDINATION AGREEMENT AND THIS GRANT, THE TERMS OF THE SUBORDINATION AGREEMENT SHALL GOVERN AND CONTROL.

**WHEREAS**, Ready Pac Foods, Inc., a Delaware corporation (the "**Company**") entered into the Purchase Agreement dated as of August 3, 2005 (as amended by the First Amendment to Purchase Agreement dated as of August 8, 2006 and the Second Amendment to Purchase Agreement dated as of September 29, 2006, collectively, the "**Original Agreement**") among the Company, the Guarantors, Private Capital Partners LLC (the "**Original Purchaser**") and Black Canyon Capital LLC, as collateral agent (the "**Original Collateral Agent**"), pursuant to which the Company issued and sold to the Original Purchaser the Senior Secured Subordinated Notes due 2009 of the Company (the "**Original Notes**");

**WHEREAS**, pursuant to the terms of the Original Agreement, the Company executed and delivered a Security Agreement dated as of August 3, 2005 among the Company and each grantor party thereto in favor of the Original Collateral Agent (as amended, the "**Original Security Agreement**");

**WHEREAS**, in connection with the Original Security Agreement, Ready Pac Produce, Inc., a California corporation ("**RPP**"), executed and delivered a Grant of Trademark Security Interest dated as of August 3, 2005 (the "**Existing Agreement**") in favor of the Original Collateral Agent;

**WHEREAS**, prior to the execution hereof, the holders of the Original Notes (the "**Assigning Holders**") have entered into an assignment agreement (the "**Note Assignment**") with the Original Collateral Agent pursuant to which the Assigning Holders assigned all of the outstanding Original Notes to the Purchasers, following which the Original Collateral Agent resigned and the Collateral Agent was named as the successor thereto;

**WHEREAS**, in connection with the foregoing, the Original Collateral Agent shall have resigned and the Holders and the Collateral Agent shall have entered into an Amended and Restated Collateral Agency Agreement of even date herewith (the "**Collateral Agency Agreement**");

**WHEREAS**, the Company and each Guarantor listed on the signature pages thereto, have entered into an Amended and Restated Purchase Agreement dated as of April 6, 2007 (said Purchase Agreement, as it may heretofore have been and as it may hereafter be further amended, restated, supplemented or otherwise modified from time to time, being the “**Purchase Agreement**”) by and among California Commercial Financing LLC as initial purchaser (in such capacity, the “**Purchaser**”), California Commercial Financing LLC as collateral agent (in such capacity, the “**Collateral Agent**”), pursuant to which Purchaser has made certain commitments, subject to the terms and conditions set forth in the Purchase Agreement, to purchase the Notes issued by Company; and

**WHEREAS**, RPP and Salad Time, LLC, a Delaware limited liability company (“**Salad Time**”); and together with RPP, the “**Grantors**” and each a “**Grantor**”) each owns and uses in its business, and will in the future adopt and so use, various intangible assets, including the Trademark Collateral (as defined below); and

**WHEREAS**, each Grantor has executed and delivered that certain Amended and Restated Guaranty dated as of April 6, 2007 (said Guaranty, as it may heretofore have been and as it may hereafter be further amended, restated, supplemented or otherwise modified from time to time, being the “**Guaranty**”) in favor of the Collateral Agent pursuant to which such Grantor has guaranteed the prompt payment and performance when due of all obligations of Company under the Purchase Agreement and the other Note Documents; and

**WHEREAS**, pursuant to the terms of an Amended and Restated Security Agreement dated as of April 6, 2007 (said Security Agreement, as it may heretofore have been and as it may hereafter be further amended, restated, supplemented or otherwise modified from time to time, being the “**Security Agreement**”), among each Grantor, the Collateral Agent (the “**Secured Party**”) and the other grantors named therein, each Grantor created in favor of Secured Party a security interest in, and Secured Party has become a secured creditor with respect to, the Trademark Collateral;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, subject to the terms and conditions of the Security Agreement, to evidence further the security interest granted by each Grantor to Secured Party pursuant to the Security Agreement, (a) RPP hereby reaffirms its grant of security interest under the Existing Agreement; and (b) each Grantor hereby grants to Secured Party a security interest in all of Grantor’s right, title and interest in and to the following, in each case whether now or hereafter existing or in which such Grantor now has or hereafter acquires an interest and wherever the same may be located (the “**Trademark Collateral**”):

- (i) all rights, title and interests (including rights acquired pursuant to a license or otherwise) in and to all trademarks, service marks, designs, logos, indicia, tradenames, trade dress, corporate names, company names, business names, fictitious business names, trade styles and/or other source and/or business identifiers and applications pertaining thereto, owned by such Grantor, or hereafter adopted and used, in its business (including, without limitation, the registrations and applications set forth on Schedule A annexed hereto) (collectively, the “**Trademarks**”), all registrations that have been or may hereafter be issued or applied for thereon in the United States and any state

thereof and in foreign countries (including, without limitation, the registrations and applications set forth on Schedule A annex hereto) in the Trademarks in the United States and any state thereof and in foreign countries, and all goodwill of such Grantor's business symbolized by the Trademarks and associated therewith; and

(ii) all proceeds, products, rents and profits of or from any and all of the foregoing Trademark Collateral and, to the extent not otherwise included, all payments under insurance (whether or not Secured Party is the loss payee thereof), or any indemnity, warranty or guaranty, payable by reason of loss or damage to or otherwise with respect to any of the foregoing Trademark Collateral. For purposes of this Grant of Trademark Security Interest, the term "**proceeds**" includes whatever is receivable or received when Trademark Collateral or proceeds are sold, licensed, exchanged, collected or otherwise disposed of, whether such disposition is voluntary or involuntary.

Each Grantor does hereby further acknowledge and affirm that the rights and remedies of Secured Party with respect to the security interest in the Trademark Collateral granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.
