RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS ("Release") is made with reference to the First Lien Trademark Security Agreement dated August 13, 2004 (the "First Lien") by and among PlayCore Holdings, Inc., a Delaware corporation, PlayCore Wisconsin, Inc., a Wisconsin corporation, and PS Commercial Play, LLC, a Delaware limited liability company (collectively, "Grantors") and Credit Suisse (formerly known as Credit Suisse First Boston), acting through its Cayman Islands Branch ("CS") and to the Second Lien Trademark Security Agreement dated August 13, 2004 (the "Second Lien") by and among Grantors and CS.

WHEREAS, pursuant to the First Lien and Second Lien, Grantors granted security interests to CS in certain intellectual property collateral, including, without limitation, the trademark registrations and applications set forth on Exhibit A hereto (together with all goodwill symbolized thereby and associated therewith, collectively, the "Trademarks");

WHEREAS, the First Lien was recorded in the United States Patent and Trademark Office on August 20, 2004, at Reel 002920, Frame 0306, with respect to the Trademarks;

WHEREAS, the Second Lien was recorded in the United States Patent and Trademark Office on August 20, 2004, at Reel 002920, Frame 0352, with respect to the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, CS hereby acknowledges and agrees that the First Lien and the Second Lien have been terminated and all of the rights and interests of CS thereunder have been terminated, including, without limitation, all of the rights and interests of CS in and to the Trademarks, and CS releases, relinquishes and discharges any and all security interests it has against the Trademarks.

CS does hereby further authorize and consent that this Release be recorded by the Commissioner of the United States Patent and Trademark Office.



CS shall, at Grantors' expense, take all further actions, and provide to Grantors and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantors to more fully and effectively effectuate the purposes of this Release.
