To Fast Trac, Inc.:

On August 2004 Secured Parties sent a notice of default to Fast Trac, inc. (the "Debtor") announcing that all three loans referenced above (reference them above) were in default and were then due and payable. Notwithstanding this demand, the Debtor made no payment on the loans. The amounts due to Secured Parties under these loans are:
