ASSIGNMENT OF REGISTERED AND UNREGISTERED
TRADE MARKS AND INTERNET DOMAIN NAMES

THIS ASSIGNMENT is made on March 30, 2007

BETWEEN:

- (1) NEWBRIDGE CAPITAL, LLC a company incorporated in DELAWARE, whose principal office is at 301 Commerce Street, Suite 3300, Fort Worth, Texas 76102, United States (the "Assignor"); and
- (2) TPG CAPITAL, L.P., a company incorporated in Delaware, whose principal office is at 301 Commerce Street, Suite 3300, Fort Worth, Texas 76102, United States (the "Assignee").

WHEREAS:

- (A) The Assignor is the registered proprietor of the Registered Trade Marks, Unregistered Trade Marks, and Domains (as hereafter defined).
- (B) Assignor desires to assign to Assignee, and Assignee wishes to acquire and accept, the Registered Trade Marks, the Unregistered Trade Marks and Domains.

THE PARTIES AGREE as follows:

1. **DEFINITIONS**

1.1 In this Assignment:

1.2 "Domains" means the internet domain name registrations and applications details of which are set out in Schedule 1 to this Assignment;

1.3 "Registered Trade Marks" means the trade mark registrations and applications details of which are set out in Schedule 2 to this Assignment; and

1.4 "Unregistered Trade Marks" means all trade names and trade name rights, service marks and service mark rights, and brand names owned by Assignee.

2. **ASSIGNMENT**

2.1 In consideration of the payment of \$1 by the Assignee to the Assignor, and other good and valuable consideration the receipt, adequacy and sufficiency of which is hereby acknowledged, the Assignor hereby assigns and transfers to the Assignee absolutely:

2.1.1 all of its right, title and interest in the Registered Trade Marks and Unregistered Trade Marks and all legal rights and immunities (howsoever derived) attaching to the foregoing;

2.1.2 all of its right, title and interest in the Domains;

2.1.3 the right to sue for and to recover damages and other remedies in respect of any infringement of the Registered Trade Marks, Unregistered Trade Marks, and/or

Domains, as the case may be, which may have occurred before the date of this Assignment; and

2.1.4 the goodwill attaching to or associated with the Registered Trade Marks, Unregistered Trade Marks and Domains.

3. **FURTHER ASSURANCE**

3.1 The Assignor shall on request by the Assignee in writing and at the Assignee's expense do and execute or arrange for the doing and executing of, anywhere in the world, each necessary act, document and thing reasonably within its power to implement this Assignment, including, for avoidance of doubt, execute any documents necessary to record this Assignment.

3.2 If in any country the execution of a confirmatory assignment or other such document in respect of the Trade Marks would be ineffective or invalid by reason of the transfer effected hereby, then this Assignment shall be deemed to be an agreement to assign and not an assignment of the Trade Marks in that country.

4. **GOVERNING LAW**

4.1 This Assignment is governed by and shall be construed in accordance with the laws of the State of New York, United States, without giving effect to any choice of law or conflict of law provision or rule (whether of the State of New York or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than the State of New York.

4.2 The parties agree that the state and federal courts of the State of New York, County of New York, are to have exclusive jurisdiction to settle any dispute relating to this Assignment and each party hereby submits to the exclusive jurisdiction of the state and federal courts of the State of New York, County of New York.
