SECURITY INTEREST IN U.S. TRADEMARK RIGHTS

THIS RELEASE OF SECURITY INTEREST IN U.S. TRADEMARK RIGHTS ("Release") is made with reference to the Grant of Security Interest in U.S. Trademark Rights dated March 24, 2005 (the "Grant") by and between HUNTER FAN COMPANY, a Delaware corporation, ("Grantor") and JPMORGAN CHASE BANK, N.A. ("Agent").

WHEREAS, in connection with the Credit Agreement dated as of March 24, 2005 among Grantor, Agent and certain other banks and financial institutions and entities from time to time parties thereto ("Lenders"), Grantor executed and delivered a Guarantee and Collateral Agreement, dated as of March 24, 2005, in favor of the Agent (the "Guarantee and Collateral Agreement");

WHEREAS, pursuant to the Guarantee and Collateral Agreement, Grantor pledged and granted to the Agent for the benefit of the Agent and the Lenders a continuing security interest in certain intellectual property collateral, including, without limitation, the trademark registrations and applications set forth on Schedule A hereto (together with all goodwill symbolized thereby and associated therewith, collectively, the "Trademarks"), and executed and delivered the Grant for the purpose of recording such security interest with respect to the Trademarks with the United States Patent and Trademark Office;

WHEREAS, the Grant was recorded in the United States Patent and Trademark Office on April 11, 2005, at Reel 003064, Frame 0028, with respect to the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby acknowledges and agrees that the Grant has been terminated and all of the rights and interests of Agent thereunder have been terminated, including, without limitation, all of the rights and interests of Agent in and to the Trademarks, and Agent releases, relinquishes and discharges any and all security interests it has against the Trademarks.

Agent does hereby further authorize and consent that this Release be recorded by the Commissioner of the United States Patent and Trademark Office.

Agent shall, at Grantor's expense, take all further actions, and provide to Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantor to more fully and effectively effectuate the purposes of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York.
