Pursuant to the provisions of Sections 3.051 to 3.056 and Sections 21.053 to 21.054 of the Texas Business Organizations Code (the "TBOC"), Allis-Chalmers Rental Tools, Inc., a Texas corporation (the "Company"), hereby adopts the following Certificate of Amendment to the Articles of Incorporation of the Company.

Article 1 - Entity Information

The name of the filing entity is Allis-Chalmers Rental Tools, Inc.. The filing entity is a corporation. The file number issued to the filing entity by the secretary of state is 0046281400 and the date of formation of the entity is February 6, 1979.

Article 2 - Amendment

Article 1 of the Articles of Incorporation of the Company is hereby amended to read in its entirety as follows:
