**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

**THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (this "Release") is made as of April 30, 2007 ("Effective Date") by and between **PNC Bank, National Association** in its capacity as Agent, as defined in the Credit Agreement (as referred to below) ("Grantee"), and **Blair Corporation, Blair Holdings, Inc., Blair Payroll, LLC, Blair Credit Services Corporation, and Blair International Holdings, Inc.** ("Grantor").

**WHEREAS**, pursuant to the terms and conditions of that certain Patent, Trademark and Copyright Security Agreement ("Security Agreement") by and between Grantor and Grantee dated December 20, 2001, Grantor granted to Grantee a continuing security interest in and to each of Grantor's present and future right, title and interest in and to the following: (i) all trade names, patent applications, patents, trademarks, trademark applications and copyrights, whether now owned or hereafter acquired by Grantor, including, without limitation, those referred to on Schedule A hereto, including all proceeds thereof, the right to sue for past, present or future infringements, all rights corresponding thereto throughout the world and all reissues, divisions, continuations, renewals, extensions and continuations-in-part thereof, and the goodwill of the business to which any of the patents, trademarks and copyrights relate (collectively, the "Patents, Trademarks and Copyrights").

**WHEREAS**, Grantor and Grantee entered into the Security Agreement pursuant to the terms and conditions of that certain Credit Agreement by and between Grantor and Grantee dated December 20, 2001 (the "Credit Agreement");

**WHEREAS**, the Security Agreement was recorded with the United States Patent and Trademark Office ("PTO") on February 26, 2002 at **Reel/Frame 2453/0360**; and

**WHEREAS**, Grantor has paid all of its outstanding indebtedness to Grantee.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates the Security Agreement, and hereby terminates, cancels and releases any and all security interests it has against the Patents, Trademarks and Copyrights.


