TRADEMARK RELEASE, effective as of this 15 day of June, 2007, given by Credit Suisse, Cayman Islands Branch (formerly Credit Suisse First Boston), as Administrative Agent ("Agent") with principal offices at Eleven Madison Avenue, 5th Floor, New York, NY, 10010, to Thrifty, Inc., an Oklahoma corporation ("Grantor"), with principal offices at 5310 E. 31st St., Tulsa, OK, 74135, as follows:

**WITNESSETH**


