## TRADEMARK SECURITY AGREEMENT

This 29th day of June 2007, American Builders & Contractors Supply Co., Inc. a Delaware corporation ("*Debtor*") with its principal place of business and mailing address at 1195 Prince Hall Drive, Suite B, Beloit, Wisconsin 53511, in consideration of ten dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, herewith grants to Wells Fargo Bank Northwest, N.A., a National Banking Association, federally chartered, with a mailing address at MAC U1228-120, 299 South Main Street, 12th Floor, Salt Lake City, Utah 84111, Attn: Corporate Trust Services, as collateral trustee under that certain Collateral Indenture and Security Agreement (the "*Collateral Indenture*"), bearing an even date herewith, on behalf of the Note Holders described below, and its successors and assigns ("*Secured Party*"), a security interest in the following property:

- (i) Each trademark, trademark registration, and trademark application listed on Schedule A-1 hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, and trademark application; and
- (ii) Each trademark license listed on Schedule A-2 hereto and all royalties and other sums due or to become due under or in respect of each such trademark license, together with the right to sue for and collect all such royalties and other sums; and
- (iii) All proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark or trademark registration listed on Schedule A-1 hereto or of any trademark licensed under a trademark license listed on Schedule A-2 or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark license, in each case together with the right to sue for injunctive and other relief including collecting said damages;

to secure performance of all obligations of Debtor as set out in a Note Purchase Agreement (the "*Note Purchase Agreement*") bearing an even date herewith among Debtor and certain institutional investors listed in Schedule A thereto (the "*Note Holders*").

Notwithstanding anything herein to the contrary, this Trademark Security Agreement shall not operate as a sale, transfer, conveyance, or other assignment to Secured Party of any applications by Debtor for a Trademark that is based on an intent to use the same, if and for so long as such application is pending without a Statement of Use having been filed and accepted (such pending applications which are based on intent to use being hereinafter referred to collectively as "*Intent-To-Use Applications*"), but rather, if and so long as Debtor's Intent-To-Use Application is pending without a statement of use having been filed and accepted, then this Trademark Collateral Agreement shall operate only to create a security interest for collateral purposes in favor of Secured Party on such Intent-To-Use Application as collateral security for the

Obligations. When a Statement of Use is filed and accepted by the Trademark Office, then that application shall cease to be partly exempted from this Agreement.

Debtor does hereby further acknowledge and affirm that the rights and remedies of the Secured Party and the Note Holders with respect to the assignment, mortgage, pledge, and security interest in the trademarks, trademark registrations, trademark applications, and trademark licenses made and granted hereby are more fully set forth in the Collateral Indenture and the Note Purchase Agreement.



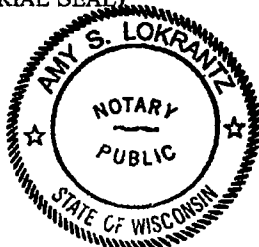

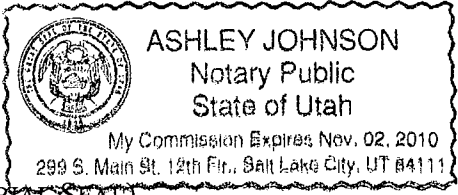
