#### TRADEMARK ASSIGNMENT

This Trademark Assignment ("Assignment") is effective as of this 3rd day of July, 2007 (the "Closing Date").

Capitalized terms used herein not otherwise defined herein shall have their respective meanings as set forth in Stock Purchase Agreement;

WHEREAS, pursuant to that certain Stock Purchase Agreement, dated May 2, 2007 (the "Stock Purchase Agreement"), Assignor agrees to sell, convey, transfer, assign and deliver its rights, title and interest, free and clear of Liens other than Permitted Liens, in and to the Purchased IP to Restore Acquisition Corp., a Delaware corporation ("Assignee"); and

WHEREAS, pursuant to the Stock Purchase Agreement, Assignee agrees to acquire Assignor's rights, title and interest, free and clear of Liens other than Permitted Liens, in and to the Purchased IP.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged,

- 1. Pursuant to and in accordance with Section 2.1(b) of the Stock Purchase Agreement, Assignor hereby sells, conveys, transfers, assigns and delivers, effective as of the Closing Date, to Assignee, its successors and assigns, all of its rights, title, interest and ownership in and to the Purchased IP free and clear of all Liens other than Permitted Liens and said registrations and applications, together with the goodwill of the business symbolized by such Purchased IP and all rights, privileges, claims, causes of action and options relating or pertaining to the Purchased IP including, without limitation, damages and payments for past and future infringements, and all rights corresponding to any of the above throughout the world.
- 2. Assignee is to hold all right, title and interest in and to the Purchased IP as fully and exclusively as it would have been held and enjoyed by Assignor had the assignment in this Assignment not been made.
- 3. This Assignment shall be deemed effective as between the parties as of the Closing Date in all countries and jurisdictions set forth on Schedule A. Assignor will, without additional consideration, take such further actions and execute promptly such further documents as may be reasonably requested by Assignee to transfer, vest, record and perfect good, valid and marketable title to the Purchased IP (subject to any Permitted Liens) and the related rights in Section 1 in Assignee. Assignor hereby authorizes Assignee to request the relevant government entity or agency, in each applicable country or jurisdiction, to record Assignee as the assignee and owner thereof.

Assignor hereby requests the relevant government entity or agency with responsibility for registering or recording interests in intellectual property, in each applicable country or jurisdiction to issue the Certificate of Registration or Renewal or similar documents, for any registration or application included in the Purchased IP, to Assignee, its successors, and assigns, in accordance with the terms of this Assignment.
- 5. The interpretation and construction of this Assignment, and all matters relating hereto, shall be governed by the laws of the State of Delaware applicable to agreements executed and to be performed solely within such State.
- 6. This Assignment may be executed in several counterparts, each of which shall be deemed to be an original, and all of which together shall be deemed to be one and the same instrument.
