**Re: Payoff of Loan and Release of Liens**

Ladies and Gentlemen:

Reference is made to the Credit Agreement, dated as of October 13, 2005 (as amended to date, the "Credit Agreement"), among you, certain of your subsidiaries, the lenders party thereto and Patriarch Partners Agency Services, LLC, as agent thereunder (in such capacity, "Patriarch"). This letter will confirm that upon receipt of \$10,080,638.31, all of your existing obligations under the Credit Documents (as defined in the Credit Agreement) will be satisfied in full and all such Credit Documents will be terminated, except for provisions thereof which, by the express terms of any such Credit Document, survive the termination of such Credit Documents. For each day after October 11, 2006 of the amount set forth above is not received by the undersigned, you will owe interest in the amount of \$4,533.33, and such interest must be paid in full to satisfy your obligations under and to so terminate the Credit Documents.

Upon receipt of the foregoing amounts, all of Patriarch's liens on and security interests in your property and the property of your affiliates/subsidiaries granted or created pursuant to any of the Credit Documents, shall be deemed to have automatically been terminated and released and you hereby have the authority to file such Uniform Commercial Code ("UCC") termination statements, and other releases, terminations, assignments, and satisfactions of Patriarch's liens on and security interests in your property and the property of your affiliates/subsidiaries as are necessary to evidence the satisfaction of your obligations under the Credit Documents and the termination of Patriarch's interest in all collateral held with respect thereto. Patriarch agrees, at your sole cost and expense, to execute and deliver any and all such further documents and instruments as are necessary to effect the release of such liens or other encumbrances.

This letter shall be governed by, and construed in accordance with, the laws of the State of New York.
