## NUN PRO TUNC TRADEMARK ASSIGNMENT

WHEREAS, Zurn Industries, Inc. ("Assignor"), a Pennsylvania corporation, and American Enterprises MPT L.P. ("Assignee"), a Delaware limited partnership, were parties to an Asset Purchase Agreement dated October 15, 1996 ("Agreement") through which Assignee acquired certain assets of Assignor including certain trademarks and/or service marks ("Trademarks") and related registrations and applications for registration of the Trademarks;

WHEREAS, Assignor executed a formal assignment ("Previous Assignment") on July 18, 1997 relating to certain of the Trademarks and related U.S. registrations and prepared for the purposes of recording the acquisition of the U.S. registrations by Assignee with the U.S. Patent and Trademark Office;

WHEREAS, Assignee changed its name to Ameridrives International L.P. on April 25, 1997 prior to execution of the Previous Assignment; and,

WHEREAS, the relative dates of the Previous Assignment and Assignee's change in name may cause confusion regarding the chain of title regarding the U.S. registrations and the parties wish to clarify the chain of title through this nun pro tunc assignment from Assignor to Assignee dated as of the October 15, 1996 date of the Agreement;

NOW THEREFORE, for good and valuable consideration including that consideration set forth in the Agreement, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby agrees as follows:

Assignor, as of October 15, 1996, assigns, sells and sets over unto the Assignee, its successors, legal representatives and assigns, the entire right, title, and interest to, any and all rights and privileges associated with the Trademarks, including the registrations for the Trademarks set forth on the attached Exhibit A, together with the goodwill of the business symbolized thereby and the right to bring suit and collect damages for past infringements thereof. Assignor hereby covenants and agrees that the Assignor will at any time upon the request and at the expense of the Assignee execute and deliver any and all papers and do all lawful acts that may be necessary or desirable to perfect said right, title, and interest and said rights and privileges in Assignee, its successors, assigns and legal representatives.
