**NOTICE OF RELEASE OF SECURITY INTEREST**

WHEREAS, Nine West Development Corporation ("Nine West") and Citibank, N.A. entered into a Subsidiary Security Agreement ("Security Agreement"), dated August 2, 1996;

WHEREAS, pursuant to the Security Agreement, Nine West granted Citibank, N.A., as administrative agent for the financial institutions party to the Credit Agreement (as such term is defined in the Security Agreement) (hereinafter "Citibank"), a security interest in Nine West's right, title and interest in and to certain United States trademarks (the "Trademarks"), as security for the payment and performance of certain secured obligations, and to induce the loans to be made and financing agreements to be issued;


WHEREAS, notice of the security interests in the Trademarks was given pursuant to the Security Agreement, which was filed and recorded in the U.S. Patent and Trademark Office on August 29, 1996 at Reel 1513, Frame 0142;

WHEREAS, the indebtedness secured by the Trademarks and the Collateral (as such term is defined in the Security Agreement) pursuant to the Security Agreement has been fully satisfied;

WHEREAS, Citibank desires to release the Security Agreement and its security interest in the Trademarks and the Collateral; and

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, Citibank hereby relinquishes, releases and terminates any and all claims and security interests that Citibank may have in any property obtained pursuant to the Security Agreement, including the Trademarks identified in Schedule A attached hereto.
