**PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "**Partial Release**") is made as of August 30, 2007 ("**Effective Date**") by MERRILL LYNCH CAPITAL, a division of Merrill Lynch Business Financial Services Inc., as Administrative Agent for the Lenders, (the "**Grantee**").

**WHEREAS**, DESA, LLC, a Florida limited liability company and successor by merger to DESA US, LLC, HIG-DESA Heating, Inc., HIG-DESA Specialty, Inc. and HIG-DESA FMI, Inc. ("**DESA**"), individually as a Borrower and as Funds Administrator, DESA HEATING, LLC, a Florida limited liability company ("**DESA Heating**"), DESA SPECIALTY, LLC, a Florida limited liability company ("**DESA Specialty**"), DESA FMI, LLC, a Florida limited liability company ("**DESA FMI**"), DESA IP, LLC, a Florida limited liability company ("**DESA IP**" or "**Grantor**"; DESA IP, together with DESA, DESA Heating, DESA Specialty and DESA FMI are hereinafter referred to individually as a "**Borrower**" and collectively as the "**Borrowers**"), DHP HOLDINGS II CORPORATION, a Delaware corporation ("**Holdings**"), DHP ACQUISITION CORP., a corporation organized under the laws of the Cayman Islands ("**Parent**" and together with each Borrower and Holdings, the "**Credit Parties**" and individually as a "**Credit Party**"), Administrative Agent, ING Capital LLC, as Documentation Agent, CIBC Inc., as Syndication Agent, and the Lenders party thereto from time to time (the "**Lenders**") have entered into that certain Credit Agreement, dated as of December 6, 2004, (as amended, restated, supplemented or otherwise modified prior to the date hereof and hereafter from time to time, the "**Credit Agreement**");

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement by and between Grantor and Grantee dated December 6, 2004 (as amended, the "**Trademark Security Agreement**"), Grantor granted to Grantee a continuing security interest in and to all of Grantor's right, title and interest in and to all of the trademarks, and registrations of and applications to register the foregoing, and all of the trade names and assumed names owned by Grantor set forth on Schedule A attached hereto (the "**Specified Trademarks**"), in each case, together with the goodwill associated therewith;

**WHEREAS**, Grantor and Grantee entered into the Trademark Security Agreement pursuant to the terms and conditions of that certain Security Agreement by and among Grantor, certain of Grantor's affiliates, and Grantee dated December 6, 2004 (as amended, the "**Security Agreement**");

**WHEREAS**, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office ("**PTO**") on December 13, 2004 at Reel/Frame 2991/0177, on April 4, 2007 at Reel/Frame 3514/0119; and an amendment thereto dated December 15, 2005 was recorded on December 20, 2005 at Reel/Frame 3214/0332; and

**WHEREAS**, pursuant to that certain Asset Purchase Agreement, dated as of August 6, 2007 (the "**Asset Purchase Agreement**"), by and among DESA, LLC, DESA Specialty, LLC, DESA Heating, LLC, DESA IP, LLC, DESA (UK) Limited, DESA Europe B.V., HIG-DHP Barbados, Ltd., and DESA Industries of Canada, Inc., as Sellers, and

Duchossois Industries, Inc., as Buyer, the Sellers have sold to Buyer the Heath-Zenith Business and Acquired Assets, as defined and more fully described therein.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates, cancels and releases any and all security interests it has against the Specified Trademarks; provided that Grantee, on its behalf and on behalf of the Lenders, terminates, cancels and releases its security interests only upon the Specified Trademarks that are "Acquired Assets" in the Asset Purchase Agreement.

Nothing herein is, or shall be deemed, a termination, cancellation, release or other modification of Administrative Agent's or any Lender's security interest or lien on any other asset of any Credit Party, including, without limitation, the "Excluded Assets" or "Retained Businesses" as defined in the Asset Purchase Agreement. Except as to the Specified Trademarks that are "Acquired Assets" in the Asset Purchase Agreement, the security interests and liens of the Administrative Agent and Lenders in any asset of any Credit Party continue in full force and effect to the same extent as if this Partial Release had not been provided.


