WHEREAS, in connection with the consummation of the transaction described in the Agreement, Assignor desires to assign, transfer and convey all right, title and interest in and to the Marks, and Unilin desires to acquire all right, title and interest in and to the Marks.

NOW, THEREFORE, in consideration of the promises and covenants in the Agreement and this Trademark Assignment, and other good and valuable consideration, the receipt and sufficiency of which the parties acknowledge, Assignor does hereby assign, transfer and convey to Unilin, its successors, assigns, and legal representatives, all right, title and interest in and to the Marks, including all registrations and applications for registration thereof and common law rights therein, together with the goodwill of the business symbolized by the Marks, and all rights of action accrued and to accrue under and by virtue hereof, including the right to sue and recover for past infringement of the Marks. Assignor further agrees to execute all documents necessary to perfect such rights, title, and interest in Unilin, its successors, assigns, and legal representatives.

IN WITNESS WHEREOF, Assignor has caused this Trademark Assignment to be executed by a duly authorized corporate officer to be effective as of August 13 2007.



