TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

WHEREAS, the Grant of Security Interest in Patent Rights was recorded in the United States Patent and Trademark Office, including but not limited to, on March 29, 2005 at Reel/Frame 015829/0689.

WHEREAS, the Grant of Security Interest in Trademark Rights was recorded in the United States Patent and Trademark Office, including but not limited to, on March 29, 2005 at Reel/Frame 3054/0630.

WHEREAS, Assignor wishes to provide a document suitable for recording in the United States Patent and Trademark Office for purposes of recording the release, relinquishment and discharge of its security interest in the Released IP Collateral.

NOW THEREFORE, in consideration of the premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby agree as follows:

- 3. <u>Further Assurances</u>. Assignor hereby agrees, at Assignee's expense, to execute and deliver to Assignee such instruments and to take such other actions as Assignee may reasonably request to terminate Assignor's security interest in the Released IP Collateral, and otherwise to effectuate the release of the Released IP Collateral from Assignor's security interest.

- 5. <u>Execution in Counterparts</u>. This Termination and Release of Security Interest in Intellectual Property may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.
- 6. <u>Governing Law.</u> This Termination and Release of Security Interest in Intellectual Property and the rights and obligations of the parties under this Termination and Release of Security Interest in Intellectual Property shall be governed by, and construed in accordance with and governed by the laws of the state of New York.
