- 6) Marcia Voudren is free to sell her licensed rights to the name "Fit Chicks" as granted under this agreement at any time however if she plans on selling the rights she must notify Michael Grant in writing sixty (60) days prior to the sale and Michael Grant has the right of first refusal to match any offer.
