**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

(Term C / JPI)

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (the "Release") is made and effective as of the date indicated below and is granted by U.S. BANK NATIONAL ASSOCIATION, as collateral agent ("Releasor") under the Financing Agreement referred to below, in favor of JACKSON PRODUCTS, INC. ("Releasee").

**WHEREAS**, pursuant to that certain Note Purchase Agreement, dated February 11, 2004, entered into by certain persons as purchasers (such persons, collectively, the "Lenders"), and the Releasee and each other signatory thereto identified to be an "Issuer" (Releasee and each such other Issuer being herein referred to as "Companies") (as thereafter amended from time to time, the "Financing Agreement"), the Lenders agreed to purchase notes from the Companies and appointed, pursuant to that certain Collateral Agency Agreement, dated as of February 11, 2004, the Releasor to act as collateral agent for the Lenders;

**WHEREAS**, Releasee and Releasor entered into that certain Trademark Security Agreement dated as of February 11, 2004 (as recorded at the U.S. Trademark Office at Reel 2933, Frame 0078), as amended by (i) that First Amendment to Trademark Security Agreement, dated August 27, 2004 (as recorded at Reel 2956, Frame 0661) and (ii) that certain Second Amendment to Trademark Security Agreement, dated as of June 1, 2005 (as recorded at Reel 3174, Frame 0454) (as so amended, the "Security Agreement");

**WHEREAS**, Releasee has requested that Releasor release and discharge fully its security interest in and to that portion of the Trademark Collateral listed on Schedule A hereto (the "Scheduled Collateral") conveyed to Releasor pursuant to the Security Agreement and/or any other agreement (the "Security Interest"); and

**WHEREAS**, Releasor is willing to release and discharge fully the Security Interest in the Scheduled Collateral.


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Releasor, on behalf of itself, its successors, legal representatives and assigns, hereby releases and discharges fully the Security Interest in the Scheduled Collateral and Releasor hereby reassigns any and all such right, title and interest that it may have in the Scheduled Collateral (if any) to Releasee.

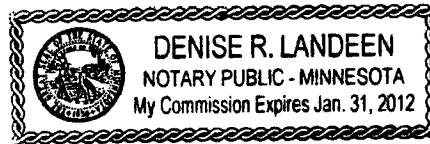
