ASSIGNMENT AGREEMENT

This Agreement is entered into as of October 10, 2007 (the "Effective Date") between Stephen R. Turrini, an individual, residing at 5 Vida Descansada, Orinda, CA 94563 ("Assignor") and FT 245 Corporation, a New York corporation, having a principal place of business at 175 Second Avenue, New York, NY 10003 ("Assignee").

For good and valuable consideration, the receipt and sufficiency of which are hereby conclusively acknowledged, Assignor does hereby sell, assign, transfer and set over to Assignee all its right, title and interest in, to and under said Mark, including U.S. Application Nos. 78/773669 and 78/892855 for VELOCE and VELOCE & Design and any registration resulting therefrom, together with the goodwill of the business symbolized by the Mark, together with all rights and privileges granted and secured thereby, including the right to sue and recover for any past infringement, said rights to be held and enjoyed by Assignee, for its own use and benefit and for the use and benefit of its successors, assigns or other legal representatives as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made.


