#### **BILL OF SALE**

This BILL OF SALE (this "Bill of Sale") is made and delivered as of March 5, 2007, by McClatchy Management Services, Inc., a Delaware corporation ("Seller"), for the benefit of Snowboard Acquisition Corporation, a Delaware corporation ("Buyer").

Except as set forth in the Purchase Agreement, Buyer hereby acknowledges that Seller makes no representations or warranties hereby with respect to the Transferred IP.

# 2. Miscellaneous.

- (a) <u>Definitions</u>. Capitalized terms used but not defined herein shall have the meanings ascribed to them in the Purchase Agreement.
- (b) <u>Headings</u>. The section headings used herein are inserted for convenience only and shall not affect in any way the meaning or interpretation of this Bill of Sale.
- (c) <u>Governing Law</u>. This Bill of Sale shall be governed by, and construed in accordance with, the laws of the State of Delaware without regard to principles of conflict of laws.
- (d) <u>Counterparts</u>. This Bill of Sale may be executed in two or more counterparts, each of which shall be deemed an original but all of which together will constitute one and the same instrument.
- (e) <u>Amendments</u>. No amendment or modification of this Bill of Sale shall be effective unless it is set forth in writing and signed by each of the parties hereto.
- (f) <u>Successors and Assigns</u>. This Bill of Sale is executed by, and shall be binding upon, the parties hereto and their respective successors and assigns for the uses and purposes above set forth and referred to herein, as of the date hereof.
