PARTIAL RELEASE OF INTELLECTUAL PROPERTY

This Partial Release of Intellectual Property from the Patent and Trademark Security Agreement (this "Termination"), dated as of October 12, 2007, is executed by Bank of America, N.A., as Administrative Agent ("Secured Party"), located at 800 5th Avenue, 32nd Floor, Seattle, Washington, 98104, in favor of CNET Networks, Inc., a Delaware corporation (the "Company"), located at 235 Second St., San Francisco, CA 94105.

RECITALS

WHEREAS, Company, certain Lenders and Secured Party, as Agent, entered in a certain Credit Agreement, dated as of October 12, 2007 (the "Credit Agreement");

WHEREAS, in connection with the Credit Agreement, Company and Secured Party entered into a certain Patent and Trademark Security Agreement dated as of October 12, 2007 (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, Company granted to Secured Party a security interest in certain "Collateral" including certain trademarks; and

WHEREAS, the Company has requested that, in connection with a disposition permitted under the Credit Agreement, certain trademarks, described on Exhibit A hereto, the "Released Collateral," be released from the security interest granted pursuant to the Security Agreement.

NOW, THEREFORE, Secured Party agrees as follows:

1. Secured Party is executing and delivering this Partial Release as further evidence of the partial release and termination of its security interest in the Released Collateral.
2. Secured Party claims no right, title or interest whatsoever in or to any of the "Released Collateral" described in the Security Agreement, and, accordingly, Secured Party expressly terminates its security interest in the Released Collateral, which security interest was evidenced by the recordation of the Security Agreement with the United States Patent and Trademark Office on October 22, 2007, in Reel/Frame 003644-0136.
