## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS is dated as of October 31, 2007 by American Capital Financial Services, Inc., as Collateral Agent ("American Capital").

WHEREAS, American Capital, Microflex Corporation, a Delaware corporation, Foodhandler Inc., a New York corporation, and BarrierSafe Solutions International, Inc., a Delaware corporation (collectively, the "Debtors"), entered into that certain Assignment of Security Interest in United States Trademarks and Patents, dated as of September 14, 2004 (the "Grant of Security Interest") and that certain Corrective Assignment, dated as of April 18, 2005 (the "Corrective Recordation");

WHEREAS, the Grant of Security Interest and Corrective Recordation granted American Capital a security interest in, among other things, the United States trademarks, trademark registrations, and trademark applications (the "Marks"), set forth on Schedule A attached hereto, in each case, together with the goodwill of the businesses with which the Marks are associated, as security for certain obligations of the Debtors to American Capital (the "Obligations") as set forth in the Security Agreement among the Debtors and American Capital, dated as of September 14, 2004 (as amended from time to time, the "Security Agreement");

WHEREAS, the Grant of Security Interest was recorded on September 27, 2004 at Reel 3051, Frame 0836 in the United States Patent and Trademark Office (the "PTO") and the Corrective Recordation was recorded on April 18, 2005 at Reel 3097, Frame 0187, in the PTO; and

WHEREAS, the Debtors have satisfied all of the Obligations and have requested that American Capital release its security interests in the Trademarks.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, American Capital hereby agrees as follows:

American Capital hereby terminates the Grant of Security Interest and the Corrective Recordation, and hereby fully releases and terminates any and all of its security interests in and liens on:

- (a) the Marks set forth on Schedule A attached hereto, in each case, together with
- (b) all Proceeds (as such term is defined in the Security Agreement) and products of the Marks,
- (c) the goodwill of the businesses with which the Marks are associated, and
- (d) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.
