**AMENDED AND RESTATED  
PATENT AND TRADEMARK SECURITY AGREEMENT**

This Amended and Restated Patent and Trademark Security Agreement (this "Agreement"), dated as of November 1, 2007, is made by and among Genmar Holdings, Inc., a Delaware corporation, Minstar, Inc., a Delaware corporation, Triumph Boat Rentals, L.L.C., a Delaware limited liability company, Carver Boat Corporation, L.L.C., a Delaware limited liability company, Genmar Industries, Inc., a Delaware corporation, Wood Manufacturing Company, Inc., an Arkansas corporation, Four Winns Boats, L.L.C., a Delaware limited liability company, Genmar IP LLC, a Delaware limited liability company, Genmar Manufacturing of Kansas, Inc., a Delaware corporation, Larson/Glastron Boats, Inc., a Delaware corporation, Seaswirl Boats, Inc., a Delaware corporation, Stratos Boats, Inc., a Delaware corporation, Triumph Boats, Inc., a Delaware corporation, VEC Technology, Inc., a Delaware corporation, Wellcraft Marine Corp., a Delaware corporation, VEC Management Co., L.L.C., a Delaware limited liability company, VEC Leasing Services, L.L.C., a Delaware limited liability company, Genmar Transportation, Inc., a Delaware corporation, Windsor Craft Yachts, L.L.C., a Delaware limited liability company, Carver Italia, L.L.C., a Delaware limited liability company, Carver Yachts International, L.L.C., a Delaware limited liability company, Marine Media, LLC, a Delaware limited liability company, and Carver Industries, LLC, a Delaware limited liability company (the "Debtors" and each a "Debtor") and Wells Fargo Bank, National Association, a national banking association, acting through its Wells Fargo Business Credit operating division, in its capacity as administrative agent for certain banks and financial institutions (the "Lenders"), having a business location at the address set forth below next to its signature (in such capacity as administrative agent, together with any successor thereto in such capacity, the "Secured Party").

**RECITALS**

The Debtors, the Lenders and the Secured Party are parties to an Amended and Restated Credit and Security Agreement of even date herewith (as the same may be amended, supplemented, restated or modified from time to time, the "Credit Agreement") setting forth the terms on which the Lenders may now or hereafter make advances or extend other credit accommodations to or for the account of the Debtors, which Credit Agreement amends and restates that certain Credit and Security Agreement dated as of July 1, 2005 among the Secured Party and certain of the Debtors, as amended (the "Prior Credit Agreement").

In connection with the Prior Credit Agreement, certain of the Debtors previously executed and delivered to the Secured Party that certain Patent and Trademark Security Agreement dated as of July 1, 2005 (the "Prior Agreement").

As a condition to entering into the Credit Agreement and to making advances and extending other credit accommodations to or for the account of the Debtors pursuant to the Credit Agreement, the Lenders and the Secured Party have required, among other things, that the Debtors enter into this Agreement, which constitutes an amendment to, and a complete restatement of, the Prior Agreement.

ACCORDINGLY, in consideration of the mutual covenants contained in the Credit Agreement and herein, the parties hereby agree as follows:

1. Definitions. All terms defined in the Recitals hereto or in the Credit Agreement that are not otherwise defined herein shall have the meanings given to them therein, with such definitions being incorporated by reference. In addition, the following terms have the meanings set forth below:

“Event of Default” has the meaning given such term in the Credit Agreement.

“Lender Parties” has the meaning given such term in the Credit Agreement.

“Obligations” has the meaning given such term in the Credit Agreement.

“Patents” means all of the Debtors’ right, title and interest in each of the following related to the design, manufacture, sale and distribution of Inventory: (i) patents or applications for patents; (ii) fees or royalties with respect to each, and including without limitation the right to sue for past infringement and damages therefor; and (iii) licenses thereunder, all as presently existing or hereafter arising or acquired, including without limitation the patents listed on Exhibit A.

“Security Interest” has the meaning given in paragraph 2.

“Trademarks” means all of the Debtors’ right, title and interest in each of the following related to the design, manufacture, sale and distribution of Inventory: (i) trademarks, service marks, collective membership marks, registrations and applications for registration for each, and the respective goodwill associated with each; (ii) licenses, fees or royalties with respect to each; (iii) the right to sue for past, present and future infringement, dilution and damages therefor; and (iv) licenses thereunder, all as presently existing or hereafter arising or acquired, including, without limitation, the marks listed on Exhibit B.

2. Security Interest. Each Debtor hereby irrevocably pledges and assigns to, and grants the Secured Party, for the benefit of the Lender Parties, a security interest (the “Security Interest”), in the Patents and in the Trademarks to secure payment of the Obligations. As set forth in the Credit Agreement, the Security Interest is coupled with a security interest in the Collateral of such Debtor. This Agreement grants only the Security Interest herein described, is not intended to and does not affect any present transfer of title of any trademark registration or application and makes no assignment and grants no right to assign or perform any other action with respect to any intent to use trademark application, unless such action is permitted under 15 U.S.C. §1060.

3. Representations, Warranties and Agreements. The security interest granted pursuant to this Agreement is granted in conjunction with the security interest granted to the Secured Party pursuant to the Credit Agreement and each Debtor hereby acknowledges and affirms that the rights and remedies of the Secured Party with respect to the security interest in the Patents and Trademarks made and granted hereby are more fully set forth in the Credit

Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

4. Debtors' Use of the Patents and Trademarks. Each Debtor shall be permitted to control and manage the Patents and Trademarks, including the right to exclude others from making, using or selling items covered by the Patents and Trademarks and any licenses thereunder, in the same manner and with the same effect as if this Agreement had not been entered into, so long as no Event of Default occurs and remains uncured.

5. Miscellaneous. This Agreement can be waived, modified, amended, terminated or discharged, and the Security Interest can be released, only explicitly in a writing signed by the Secured Party. A waiver signed by the Secured Party shall be effective only in the specific instance and for the specific purpose given. Mere delay or failure to act shall not preclude the exercise or enforcement of any of the Secured Party's rights or remedies. All rights and remedies of the Secured Party shall be cumulative and may be exercised singularly or concurrently, at the Secured Party's option, and the exercise or enforcement of any one such right or remedy shall neither be a condition to nor bar the exercise or enforcement of any other. All notices to be given to the Debtors under this Agreement shall be given in the manner and with the effect provided in the Credit Agreement. The Secured Party shall not be obligated to preserve any rights a Debtor may have against prior parties, to realize on the Patents and Trademarks at all or in any particular manner or order, or to apply any cash proceeds of Patents and Trademarks in any particular order of application. This Agreement shall be binding upon and inure to the benefit of the Debtors and the Secured Party and their respective participants, successors and assigns and shall take effect when signed by the Debtors and delivered to the Secured Party, and the Debtors waive notice of the Secured Party's acceptance hereof. The Secured Party may execute this Agreement if appropriate for the purpose of filing, but the failure of the Secured Party to execute this Agreement shall not affect or impair the validity or effectiveness of this Agreement. A carbon, photographic or other reproduction of this Agreement or of any financing statement signed by the Debtors shall have the same force and effect as the original for all purposes of a financing statement. This Agreement shall be governed by the internal law of Minnesota without regard to conflicts of law provisions. If any provision or application of this Agreement is held unlawful or unenforceable in any respect, such illegality or unenforceability shall not affect other provisions or applications which can be given effect and this Agreement shall be construed as if the unlawful or unenforceable provision or application had never been contained herein or prescribed hereby. This Agreement constitutes an amendment to, and complete restatement of, the Prior Agreement.
