

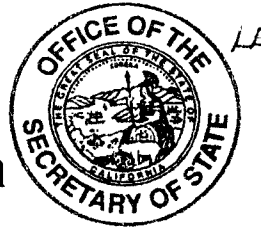

ARTICLES OF INCORPORATION OF  
PROTECTIVE OPTICS, INC.

MYLES R. FREEMAN and DANIEL W. FREEMAN certify that:

1. They are the President and Secretary, respectively, of PROTECTIVE OPTICS, INC., a California corporation.

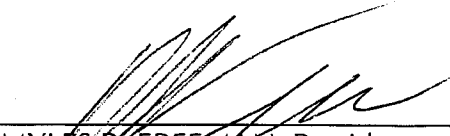
2. Article 1 of the Articles of Incorporation of this Corporation is amended to read as follows:


"1. The name of this Corporation is: WILEY X, INC."

3. The foregoing amendment of the Articles of Incorporation has been duly approved by the Board of Directors.


4. The amendment has been approved by the required vote of the Shareholders in accordance with Section 902 of the California Corporations Code. The Corporation has only two classes of shares outstanding. The Corporation has fifty thousand (50,000) shares outstanding and entitled to vote with respect to the amendment. The number of shares voting in favor of the amendment exceeded the vote required, in that the affirmative vote of a majority, that is, more than fifty percent (50%) of the outstanding shares, was required for approval of the amendment, and the amendment was approved by the affirmative vote of fifty thousand (50,000) shares, or one hundred percent (100%) of the outstanding voting shares.

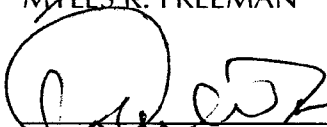
