TERMINATION AND RELEASE OF PATENT AND TRADEMARK SECURITY AGREEMENT dated as of December 6, 2007, by WELLS FARGO BANK, NATIONAL ASSOCIATION (the "Secured Party"), acting through its Wells Fargo Business Credit operating division.


WHEREAS, RMO, Inc., a Colorado corporation (the "Grantor") and the Secured Party entered into a Patent and Trademark Security Agreement, dated as of September 6, 2007 (the "Security Agreement") which Security Agreement was recorded with the United States Patent and Trademark Office on September 22, 2006, Patent Assignments at Reel 018296, Frame 0782 and Trademark Assignments at Reel 3395, Frame 0615 for the purpose of collateral security for all indebtedness and obligations of the Grantor to the Secured Party arising under a certain Credit Agreement (as defined in the Security Agreement);

WHEREAS, the Secured Party has agreed to terminate and release its security interest in the Intellectual Property as herein provided:

NOW, THEREFORE, for valuable consideration the Secured Party hereby terminates and releases its security interest in the Intellectual Property, including, without limitation, the Patents listed on Exhibit A hereto and the Trademarks listed on Exhibit B hereto, and the Secured Party hereby assigns and transfers to the Grantor, without representation, warranty or recourse, all of the Secured Party's right, title and interest in and to such Intellectual Property, effective as of the date set forth above

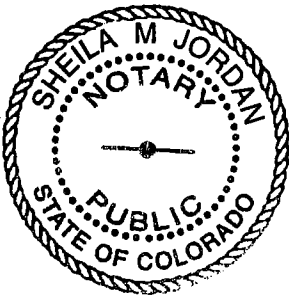
