#### NOTICE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This NOTICE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY, dated as of December 3, 2007 (this "Notice"), is made by and among (i) THE GREAT ATLANTIC & PACIFIC TEA COMPANY, INC. (the "Company"), a Maryland corporation, (ii) each subsidiary of the Company listed on Schedule I attached hereto (each such subsidiary individually a "Borrower" and collectively, the "Borrowers"), (iii) each subsidiary of the Company listed on Schedule II attached hereto (each such subsidiary individually a "Guarantor" and collectively, the "Guarantors") (the Company, the Borrowers and the Guarantors are hereinafter referred to, collectively, as the "Grantors"), and (iv) BANK OF AMERICA, N.A., a national banking association, as collateral agent (in such capacity, the "Collateral Agent") for its own benefit and the benefit of the other Secured Parties (as defined in the Security Agreement referred to below), in consideration of the mutual covenants contained herein and benefits to be derived herefrom.

#### WITNESSETH:

WHEREAS, Grantors are party to a Credit Agreement, dated as of the date hereof, in favor of the Collateral Agent and the Secured Parties (as amended, restated or otherwise modified from time to time, the "Credit Agreement");

WHEREAS, Grantors are party to a Security Agreement, dated as of the date hereof, in favor of the Collateral Agent and the Secured Parties (as amended, restated, or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, Grantors have executed and delivered this Notice for the purpose of recording and confirming the grant of the security interest of the Collateral Agent in the Intellectual Property (as defined below) with the United States Patent and Trademark Office ("PTO") and/or the United States Copyright Office;

NOW, THEREFORE, in consideration of the mutual conditions and agreements set forth herein and in the Security Agreement, and for good and valuable consideration, the receipt of which is hereby acknowledged, the Grantors and the Collateral Agent, on its own behalf and on behalf of the other Secured Parties (and each of their respective successors or assigns), hereby agree as follows:

SECTION 1. <u>Defined Terms</u>. Unless otherwise defined herein, terms used herein have the meaning given to them in the Security Agreement. The following terms shall have the following meanings:

"Copyrights" shall have the meaning given in the Security Agreement and shall include the copyrights set forth on Exhibit A.

"Intellectual Property" shall mean all intellectual and similar property of any Grantor of every kind and nature now owned or hereafter acquired by any Grantor, including inventions, designs, Patents (as defined herein), Copyrights (as defined herein), Licenses, Trademarks (as

defined herein), trade secrets, technology, confidential or proprietary technical and business information, know-how, show-how, data or information, domain names, mask works, customer lists, vendor lists, subscription lists, software and databases and all embodiments or fixations thereof and related documentation, registrations and franchises, and all additions, improvements and accessions to, and books and records describing or used in connection with, any of the foregoing.

"Patents" shall have the meaning given in the Security Agreement and shall include the patents set forth on Exhibit B.

"<u>Trademarks</u>" shall have the meaning given in the Security Agreement and shall include the trademarks set forth on Exhibit C.

SECTION 2. Grant of Security Interest. In furtherance and as confirmation of the Security Interest granted by the Grantors to the Collateral Agent (for its own benefit and the benefit of the other Secured Parties) under the Security Agreement, and as further security for the payment or performance, as the case may be, in full of the Obligations, each of the Grantors hereby ratifies such Security Interest and grants to the Collateral Agent (for its own benefit and the benefit of the other Secured Parties) a continuing security interest, in all of the present and future right, title and interest of such Grantor in, to and under its Intellectual Property, whether now owned or existing or hereafter acquired or arising, together with all products, proceeds, substitutions, and accessions thereof, including any claim by Grantors against third parties for past, present, or future infringement, dilution, misappropriation, violation, or unfair competition with any Intellectual Property (collectively, the "Intellectual Property Collateral").

SECTION 3. <u>Intent</u>. This Notice is being executed and delivered by the Grantors for the purpose of recording and confirming the grant of the security interest of the Collateral Agent in the Intellectual Property Collateral with the United States Patent and Trademark Office and/or the United States Copyright Office. It is intended that the security interest granted pursuant to this Notice is granted in conjunction with, and not in addition to or limitation of, the Security Interest granted to the Collateral Agent, for its own benefit and the benefit of the other Secured Parties, under the Security Agreement. All provisions of the Security Agreement shall apply to the Intellectual Property Collateral. The Collateral Agent shall have the same rights, remedies, powers, privileges and discretions with respect to the security interests created in the Intellectual Property Collateral as in all other Collateral. In the event of a conflict between this Notice and the Security Agreement, the terms of the Security Agreement shall control.

SECTION 4. <u>Recordation</u>. Each Grantor authorizes and requests that the Commissioner for Patents, the Register of Copyrights, and the Commissioner for Trademarks and any other applicable government officer record this Notice.

SECTION 5. <u>Collateral Agent As Attorney-In-Fact</u>. Each of the Grantors hereby irrevocably makes, constitutes and appoints the Collateral Agent (and all officers, employees or agents designated by the Collateral Agent) as and for such Grantor's true and lawful agent and attorney-in-fact in accordance with Section 5.03 of the Security Agreement:

- (a) To supplement and amend from time to time <u>EXHIBITS A</u>, <u>B</u> and <u>C</u> of this notice to include any newly developed, applied for, registered, or acquired Intellectual Property of such Grantor and any intent-to-use Trademark applications for which a statement of use or an amendment to allege use has been filed and accepted by the PTO.
- (b) To execute all such instruments, documents, and papers as the Collateral Agent reasonably determines to be necessary or desirable in connection with the exercise of such rights and remedies and to cause the sale, license, assignment, transfer, or other disposition of the Intellectual Property.

SECTION 6. <u>Termination</u>; <u>Release of Intellectual Property Collateral</u>. Upon termination of the Security Interest in the Intellectual Property Collateral in accordance with the Security Agreement, the Collateral Agent shall execute, acknowledge, and deliver to the Grantor, at such Grantor's expense, an instrument in writing in recordable form releasing the collateral pledge, grant, lien and security interest in the Intellectual Property Collateral under this Notice. Any execution and delivery of termination statements, releases or other documents pursuant to this SECTION 5 shall be without recourse to, or warranty by, the Collateral Agent or any other Secured Party.
