RELEASE OF LIEN

WHEREAS, Cross Hueller, LLC, a Michigan limited liability company (hereinafter "CROSS HUELLER"), is the owner of the Trademarks listed on Schedule I (hereinafter "Trademarks"); and,

WHEREAS, Silver Point Finance, LLC a Delaware limited liability company (hereinafter "SILVER POINT") has filed a lien against the Trademarks that has been recorded on January 19, 2006 in the records of the United States Patent and Trademark Office at Reel/Frame 3231/0802 (hereinafter "Lien"); and,

WEHREAS, CROSS HUELLER desires to have the Lien released and SILVER POINT is desirous of releasing the lien;

NOW, THEREFORE, in consideration of and in accordance with the terms of that certain Payoff Letter dated as of the date hereof, between CROSS HUELLER and SILVER POINT, and other good and valuable consideration in hand paid by CROSS HUELLER to SILVER POINT, the receipt and sufficiency of which is hereby acknowledged, SILVER POINT by these presents, does hereby i) convey all of its right, title, and interest in and to the Trademarks to CROSS HUELLER, together with the goodwill associated with the Trademarks, and ii) grant a complete release of the Lien, with no reservations whatsoever, so that CROSS HUELLER's ownership of and rights in the Trademarks will be free and clear of any encumbrances, as if the Lien had never been imposed.

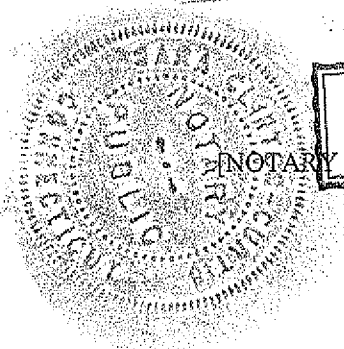
