WHEREAS, MAG International Industrial Automation Systems, S.A.R.L., a Luxembourg limited liability company, MAG International Holdings, S.A.R.L., a Luxembourg limited liability company, MAG Maintenance Technologies GmbH a.k.a. TRADEMARK OWNERS' ownership of and rights in the Trademarks will be free and clear of any encumbrances, as if the Lien had never been imposed.

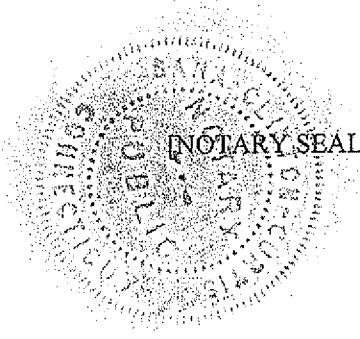
